



NFT Newspaper Summary:

1. We create a complete media content ecosystem with NFT technology at its core.
2. One goal: to create and deliver editorial value to the maximum number of readers and listeners around the world.

Eventually, our platform will offer :

Journalistic content on NFTs News produced by specialized journalists

A highly specialized daily newsletter (free and paid versions)

A decentralized Metaverse: opening up content sharing to all landowners in our 100% Media Metaverse

Learn to Earn (learn around NFTs, earning tokens)

Permanent and infinite games and collaboration with the new global NFTs projects

Many other tools that will be imagined over time to meet the expectations of our readers and our community

All our projects are centered around the creation of journalistic and informative value in order to inform 100% of the world population in a few clicks, with an infinite development objective (no objective to reach, constant growth).

To simplify financial exchanges (metaverse, learn to earn, paid content, advertising, etc.), we will create a token dedicated to our ecosystem.

To better understand who will benefit from NFT Newspaper, by profile, here are the details on the next page.

Group n°1: readers & listeners

The first group that will benefit from NFT Newspaper is all the people who are interested in NFTs and their infinite derivatives: ***readers and listeners***.

The maximum number targeted is the ***entire world population***, since we believe that NFTs and Web3 will be ubiquitous in everyone's life within 5 to 10 years.

The content will be ***mainly free***, but some content may be paid (daily newsletter long version, some content on the Metaverse Media, etc)

Our goal is to offer ***unlimited and qualitative content around NFTs and their derivatives***.

The two main places where they can enjoy the content will be :

- On our newspaper (website, etc), content written by professional journalists;
- On the decentralized **Metaverse Media** (content produced by landowners or their tenants)

Benefits:

- A comprehensive, diverse, rich and lively source of information about NFTs and their derivatives;
- An exhaustive ecosystem allowing each reader or listener to become active in the community in different ways (use of the token, learn to earn, acquisition of an NFTN ROBOT OR NFTN BABY ROBOTS on the secondary market, participation in games, etc.).

Group n°2: owners of an NFTN ROBOTS

Unlike the first group which targets hundreds of millions of monthly readers and listeners, the NFTN ROBOTS community will be **limited to 11,470**.

This group will be made up of the people who will be at the heart of the project and who will receive priority benefits indefinitely (see benefits on next page).

Group n°3: Content Producers in the Metaverse Media


Landowners in our Metaverse Media (or their tenants) will be able to easily produce and share free or paid content to their visitors. The details of this part will be explained in version 2 of the White Paper.

Group n°4: The NFTN BABY ROBOTS holders community

This community will have similar benefits to the NFTN ROBOTS Holders community, but less interesting. The NFTN ROBOTS community will always have priority.

Group n°5: Our professional partners

Our **partners will be able to advertise** (payable in NFTN Token) which will be paid to the listeners (Learn to earn) or to the owners of Lands in the Metaverse (Advertising whose earnings will be paid in large part to the content producers).



NFTN ROBOTS'

This collection is the initial project that will offer the most important benefits to owners. Here are the initial details on NFTN Robots:

- The blockchain used is POLYONG (MATIC).
- The approximate unit price will be 750 USD (Public Sale) or 500 USD (Pre-Sale).
- Drop date: available soon, during 2022
- Number of NFTN ROBOTS available for PreSale & Public Sale: 10,000
- Number of NFTN ROBOTS reserved for Marketing: 1,470
- Designer: Alisa K. (Ukraine)

We decided to use the **image of the ROBOT** to symbolize the technological advance that allows us to decentralize the way we share information and to pay content creators more fairly and automatically.

Collection value and community:



Owning a NFTN ROBOT also means belonging to the most tightly knit community in our media ecosystem: private chat, joint projects, information sharing, partnerships, etc.


